Ct. Raj Kumar from PS Ghadi Pukhta, District Shamli, UP is present with the case property. The same is directed to be deposited in the malakhana of PS Dwarka North. MHC(M) Dwarka North and Naib Court of PS Dwarka North are present and they are directed to take Ct. Raj Kumar with them to PS Dwarka North and get the case property deposited in the malakhana and necessary entries be made in register No. 19 and receipt be handed over to Ct. Raj Kumar so that he may place it in the relevant register maintained in their register.

PW5 Sh. Prem Kumar Batra is present. However, he is discharged unexamined as case property has to be seen by SI Ashok and Ld. APP and thereafter only witness can be examined. The

exercise will take long time. He be summoned again for the next date.

PW Sh. Naresh Batra be also called for the next date of hearing.

Medical report of accused Rohit Gupta received from Jail Superintendent. The same be taken on record.

MHC(M) is present. He is directed to appear with the entire case property on the next date of hearing.

An application for release of registration certificate of vehicle bearing No. DL 8CS 6444 filed by sruety/applicant Sh. Tarun Nagpal. It submitted by the counsel for the applicant that applicant has furnished his surety for the accused at the time of grant of interim bail to accused Atul Kumar and after completing the period of interim bail, accused had surrendered in JC. Heard. Today, accused has come from JC. Considering the same, let the original documents of the surety/applicant Sh. Tarun Nagpal be released to him after identification, retaining photocopy and cancellation of acknowledgement if any.

Now to come up for remaining prosecution evidence on **10.10.2018 and 11.10.2018**. Remaining PWs as per the list of witnesses be summoned through IO/SHO concerned.
