An application for extension of interim bail moved on behalf
of accused Rohit Gupta has been filed today. Heard. Perused.

Perusal of record shows that already accused was granted
interim bail previously for his treatment for sufficient time and no further
extension can be granted to him. He is present in the court and his condition
seems to be better than previously. Accused cannot be allowed to take
interim bail again and again on the same ground for which he has already
been granted relief. Hence, the application filed on behalf of accused Rohit
Gupta stands dismissed.

An application for regular bail moved on behalf of accused
Atul Kumar is pending on record. During the course of arguments, the

counsel for accused has submitted that he wants to withdraw the present bail application. He has appended his signatures on the application itself. Heard. Allowed.

Accordingly, in view of the submissions of Ld. Counsel, the present application stands disposed of as withdrawn. Accused Atul Kumar and Rohit Gupta are directed to surrender today before Jail Superintendent as period of their interim bail is expiring today. Accused Rohit Gupta is directed to return his complete medical treatment file in jail which was released to him at the time of granting interim bail for his treatment. Copy of this order be given dasti to him.

SI Hari Ram Sharma is not served. SI Hari Ram Sharma having phone No. 9639393656 be summoned from LIU Office Saharanpur.

Inspector K. P. Sharma is absent despite service. Sufficiently awaited. Let B/Ws in sum of Rs. 5000/- be issued against him to be served through SP Meerut. Show cause notice be also issued to him for next date.

Ahlmad of court Ld. CJM is unserved. He be summoned afresh with case file No. 277/14, PS-Babri, Shamli, U.P.

Be put up for PE on 23.04.2019. MHC(M) is present and is directed to appear on next date with case property. Witnesses Ct. Rambir Singh and Ct. Dheeraj be summoned for next date.
