PW -**Inspector K.K. Sharma** is not present. Let he be also summoned for next date of hearing.

Nodal Officer Idea Cellular is not present. Let B/W in sum of Rs.5,000/- be issued against him for next date of hearing.

Witness No. 7 Varun, PW-8 Ms. Kirti Anand PW 13 Nodal Officer Reliance be summoned for next date of hearing.

PWs Ct. Kuldeep and HC Manoj are not present and sent request. Ld. APP has submitted that PW-23 ASI Chaman Singh has been examined and these two witnesses namely Ct. Kuldeep and HC Manoj are of the same deposition and are not required as a witness in the present case because the fact to be proved by them has already been proved by ASI Chaman Singh. Hence, these two witnesses are dropped from the list of

witnesses.

Witness No. 21 Head Moharar PS Sardana is also not required because case property Wagon-R car has already been deposited with the Police Station Dwarka North and the witness to that effect has already deposed.

Nodal Officer Aircell is not available because Company Aircell has already been closed and there is no address of the same. Hence, in these circumstance liberty is granted to call the witness as and when he is available by the IO and the prosecution before the closing of the evidence.

The Ld. APP will go through the file and will tell that whether Inspector K.P. Sharma, Inspector O.P. Sharma, SI O.P. Kalyani, Ct. Robin, Ct. Mohd. Ilyas, Ct. Vikas Kumar are required or not in the present matter and if any of them is required summons be issued accordingly after the next date. Thereafter, SI Ashok and Inspector Ashok IOs of the case will be examined.

Be put up for PE on **11.09.2019**. Case property be also produced. Ld. Counsel for the complainant has sought time for arguments on the bail application of accused Atul. Accordingly, put up for arguments on the bail application on **06.09.2019**.
