Atul Kumar, Advocate and pointed out that an application dated 16.01.2020 seeking release of Vehicle No.DL-8C-AR-4203 (Datsun Redigo) alongwith other documents i.e. Debit Card, Credit, Aadhar Card, PAN Card, some jewellery and cash, is listed for hearing today.

Reply to the aforesaid application filed today.

Heard on the said application. Record perused.

During the course of arguments, counsel for applicant has filed original SPA purportedly executed by registered owner namely Ms. Kiran Bala in favour of applicant Pankaj Bajaj.

The reply to the application filed today, is totally silent about any of the aforesaid articles being found lying in the vehicle or having been seized in this case. Counsel for applicant, as also the applicant, submit that they are not pressing relevant part of prayer made in the application to the extent of release of articles as mentioned therein and are confining their prayer only to the extent of release of aforesaid vehicle on superdari. Their signatures be obtained in side of the proceedings in token of having made the aforesaid statement.

Counsel for applicant states at Bar that the aforesaid vehicle stands registered in the name of Ms. Kiran Bala, who is stated to be real sister of applicant/SPA Holder. He assures to file copy of insurance policy of said vehicle on record during the course of day.

Considering the entire facts and circumstances of the case and the submissions made and subject to placing on record copy of insurance policy as undertaken hereinabove, the vehicle No.DL-8C-AR-4203 (Datsun Redigo) is

directed to be released to Sh. Pankaj Bajaj, applicant/SPA holder/real brother of applicant/accused Ms. Kiran Bala, after proper verification and subject to furnishing superdarinama in the sum of Rs.2.25,000/- to the satisfaction of IO/SHO concerned and subject to the conditions that photographs of the said vehicle including that of its engine number and chassis number shall be taken before its release at the expenses of the applicant and subject to further conditions that the applicant shall not transfer or part with its possession without prior permission of the court and shall produce the same before the Court during trial as and when so required. Proper panchnama shall also be prepared before release of aforesaid vehicle on superdari, as per rules. The said photographs alongwith their negatives/CD shall be placed before the Court on or before the dates of hearing already fixed in the case. **Application stands disposed of accordingly.**
