Sh. S. S. Rawat, Ld. counsel for the applicant / accused (through VC) along with Ms. Shivani Chauhan, Advocate who is present in the Court.

SI Durgesh is also present on behalf of the IO.

1. It is submitted by the Ld. counsel for the applicant / accused that applicant / accused is an innocent person and has been falsely implicated in the present case and has nothing to do with the alleged offence. It is further submitted by Ld. counsel for the applicant/accused that applicant / accused is languishing in custody since 23.07.2019. It is further submitted by Ld. counsel for the applicant/accused that investigation is complete and no purpose would be served by keeping the applicant / accused in JC any more and hence, it is requested that present application be allowed.

2. On the other hand, Ld. Addl. PP for the State has argued on the present application and opposed the same.

3. The record reveals that applicant / accused is in custody since long time and till date, charge has not been framed for want of Sanction report. Other co-accused are on bail. Keeping in mind the custody of the applicant / accused and the fact that trial of the case will take long time and is not likely to be completed in a short span of time. Keeping in view the facts and circumstances of the case, **the present application stands allowed**. The applicant/accused is hereby granted bail on furnishing personal bond in sum of Rs.30,000/- with one surety in the like amount to the satisfaction of this Court.

5. Accused shall abide by the following conditions:-

- i) Accused shall provide permanent address to this Court. The Accused shall intimate the Court by way of an affidavit and to the IO regarding any change in residential address.
- ii) Accused shall appear before the Court as and when the matter is taken up for hearing unless exempted.
- iii) Accused shall not indulge in any criminal activity and shall not communicate with or come in contact with the complainant/victim or any member of the complainant/victim's family or tamper with the evidence of the case.
