Perusal of the file reveals that the matter has not been settled in the National Lok Adalat organized on 22.03.2026.  
Replies filed on behalf of R1 and R2.

Claimant is directed to open Savings Bank Account in a nationalized bank near the place of his residence and the concerned bank is directed not to issue any cheque book and/or debit card to the claimant and make an endorsement on the passbook of the claimant regarding cancellation or non-issuance of cheque-book and/or debit card to claimants.

Copy of order be produced before the Bank whereupon bank is directed to make aforesaid endorsement on the passbook.

Claimant is also directed to produce the abovesaid passbook with necessary endorsement along with Aadhar Card, PAN Card & E-mail ID, if any, on next date of hearing.

Following issues are settled on the basis of pleadings:

1. **Whether Smt. Meena Passy suffered fatal injury in road accident on 01.12.2025 caused due to rash and negligent driving of offending moped bearing registration No.DL-9SCF-7391 by R1/Sh. Kirtan (driver) which vehicle was registered in the name of R2/Ram Roop (owner) and insured with R3/HDFC ERGO General Insurance Company.? ...OPP**

2. **If issue No.1 is decided in affirmative, then what will constitute just compensation payable to injured and by whom?** ...OPP

3. **Relief .**

No other issue arises or is pressed for.

List of witnesses be filed preferably within a week.

Affidavit to be tendered in evidence be filed with advance copy to respondents/counsels.

Let the evidence be recorded by Ld. Local Commissioner and the expenses shall be borne by the insurance company. Evidence shall be concluded within 03 months. If any party wants to summon any witness, they can simply file PF and details with the office and obtain dasti summons.

Ld. Local Commissioner shall not grant unnecessary adjournment to any of the parties and if the Ld. Local Commissioner finds that despite scheduling a date for evidence with consent of all, any party is seeking adjournment, he shall record that such party shall be obliged to pay a cost of Rs.5000/- for every adjournment. Local Commissioner shall follow due diligence while recording the evidence and shall show respect to the parties without any bias. The fee of local commissioner shall be Rs.3000/- per witness. The fee of Local Commissioner shall be paid by the insurance company to him directly in his bank account by way of cheque/DD/NEFT.

Advocate Ms. Namrata Bhatnagar having enrollment no.D/3088/2014, (Mobile No.9810375440) is appointed as Local Commissioner.
