Today, matter is fixed for filing FSL report / consideration
of application under Section 483 BNSS moved on behalf of the applicant
/ accused Karan Singh @ Karan for grant of interim bail for a period of
15 days.

Reply has been filed of the above said application.

FSL report is still awaited.

1. As far as the application moved on behalf of applicant /
accused Karan Singh @ Karan is concerned, it is submitted by Ld.
counsel for the applicant / accused that father of the applicant / accused
was expired on 03.11.2025, and the TEHRAVI ceremony of the father of
the applicant / accused is scheduled for 14.11.2025 and being the son,

the presence of the applicant / accused is required to perform all the rituals of his father and hence, it is requested that present application be allowed and applicant / accused be interim bail for a period of 15 days.

2. On the other hand, Ld. Addl. PP for the State has argued on the present application and opposed the same on the ground that allegations against the present applicant / accused are serious in nature and prays for the dismissal of the present application.

3. The applicant / accused is claiming interim bail to perform all the rituals of his father. IO has verified the said fact and as per the report, the said fact is found to be correct that father of the applicant has expired and his Tehrahi of the applicant / accused is scheduled for 14.11.2025. Hence, in view of the submissions made above and without commenting on merits and on humanitarian grounds, the applicant is admitted to interim bail for a period of **07 days from the date of release** subject to furnishing bail bond in the sum of Rs. 20,000/- with one surety of like amount to the satisfaction of this Court. **It is made clear that no further application for regular bail / extension of bail would be entertained without surrendering before the Court.**

4. Further, accused shall abide by the following conditions:

i) Accused shall not indulge in any criminal activity and shall not communicate with or come in contact with the complainant/victim or any member of the complainant/victim's family or tamper with the evidence of the case.

5. Applicant is directed to surrender before the Jail Superintendent on the expiry of the period of interim bail. **Application stands disposed of accordingly.**

6. Director FSL Rohini is directed to expedite the matter on priority basis. Let report be again called from FSL Rohini for **16.01.2026**. Let IO be also summoned for the said date.

7. Copy of this order be given dasti to Ld. counsel for the accused, if prayed for. Copy of this order be also sent to Jail Superintendent for information and compliance.
