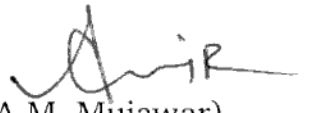

That on 19.06.2024 at about 15.30 hrs at 6, Ruby Classic building, Muleshwar Pan Bhandar, Mahavir Nagar, Kandivali (West), Mumbai, have not displayed the instructions of statutory warning of different companies on cigarettes packets, as per directions of Government of Maharashtra and thereby committed breach of Sec.7(3) of The Cigarette and Other Tobacco Product, Prohibition of Advertisement and Regulation of Trade and Commerce Production Supply and Distribution Act and thereby committed an offence punishable U/Sec.20(2) of The Cigarette and Other Tobacco Product, Prohibition of Advertisement and Regulation of Trade and Commerce Production Supply and Distribution Act.

Particulars of plea is read over and explained to accused in Hindi language.

Q.2 : Have you understood the contents of plea just now read over and explained to you ?

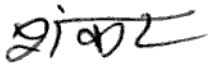
Ans : Yes.

JUDGMENT

Accused appeared before Court. Particulars of offence are read over and explained to him to which he pleaded guilty. His plea is accepted as it appears to have been made voluntarily. Accused prayed for leniency. Ld. APP submits that maximum punishment may be imposed. Considering the submissions made by both sides, I pass the following order.

ORDER

1. Accused viz. Shankar Mogji Patel is hereby convicted for the offence U/sec. 7(3) punishable u/s. 20(2) of The Cigarette and Other Tobacco Product, Prohibition of Advertisement and Regulation of Trade and Commerce Production Supply and Distribution Act, as per section 252 of Cr.P.C.
2. Accused is sentenced to pay fine of Rs. 1,000/- (Rs. One Thousand only) i.d. to suffer S.I. for 10 (ten) days, for the offence U/sec.7(3)

punishable u/s. 20(2) of The Cigarette and Other Tobacco Product, Prohibition of Advertisement and Regulation of Trade and Commerce Production Supply and Distribution Act.

3. His bail bonds, if any, stand cancelled. The amount of cash surety, if any, be refunded to the accused forthwith.
4. The seized muddemal property be disposed off, as per provisions of law, after appeal period is over.
5. Copy of the order be given free of cost to the accused.
