CLAIM: Petition is filed Under Order 21, Rule 43, 64 of C.P.C, to pass an order the DHR had filed an arbitration case against the JDRs for recovery of money arbitration No. ARC/HDB/VL/11043 and the same was allowed by the Arbitrator passed an award on 12-04-2021.
