O R D E R:-

This common order of mine shall decide three applications
for regular bail under section 483 BNSS filed in the above noted FIR
i.e. one on behalf of applicant Jatinder @ Gatti bearing CIS No. BA-
2702-2024, second on behalf of applicant Anmoldeep Singh bearing
CIS No. BA-2717-2024 and third on behalf of applicant Sunil bearing
CIS No. BA-2720-2024, on the allegations that they are innocent and

have been falsely implicated in the present case. Recovery has already been effected in the present case. Applicants/accused are in custody since 28.10.2024 and are no longer required for any further custodial interrogation. It will take long time to present the challan and thereafter, in conclusion of trial. Hence, these bail applications.

2. Notice of bail applications was issued to State and Sh. Amit Goklaney, Addl. Public Prosecutor put in appearance on behalf of State. Record has also been requisitioned.

3. I have heard arguments of learned counsel for applicants and Addl. Public Prosecutor for State and have gone through the record.

4. As per report of Filing Branch Clerk, no bail application filed by applicants/accused is pending in the Hon'ble High Court. He has attached on record copy of report downloaded from the website of Punjab and Haryana High Court.

5. As per the case of the prosecution, case was registered against applicants/accused Sehajpreet Singh and Mandeep Singh on the basis of secret information that they have formed a gang and are having firearms and are present near an abandoned sheller on Talwandi Bhai road and in case raid is conducted, then firearms can be recovered. Raid was conducted and applicant/accused Jatinder @ Gatti

was apprehended and one .32 bore pistol alongwith 7 live cartridges were recovered from his possession. Applicants/accused Anmoldeep Singh and Sunil were also apprehended and one .315 bore pistol each and one live cartilage each were recovered from their possession.

6. Applicants/accused are in custody since 28.10.2024. It will take sufficient time to present the challan and to conclude the trial. No useful purpose will be served by keeping the applicants behind bars for indefinite period. Present applications for regular bail are allowed. Applicants/accused are admitted to bail to the satisfaction of Illaqa/ Duty Magistrate. Copy of this order be placed in the files of bail application bearing CIS No. BA-2717-2024 and BA-2720-2024. Bail papers be consigned to record room.
