(Delivered on 02-06-2023)**

ORDER

The matter is suo moto advanced to this day and is placed before the National Lok Adalath. Police present. Summons served. Accused No.1 and 2 are present. Copies furnished to them. Offence alleged against the accused are punishable u.Sec.270, 273 IPC and Sec.20(2) of COPTA Act. Accused are examined u.Sec. 251 Cr.P.C and the substance of accusation is readover and explained to them in Telugu. Having understood the same, accused are pleaded guilty voluntarily. Accordingly, the accused are found guilty under Section 252 Cr.P.C. The accused are explained as to the quantum of sentence prescribed under the law. Plea of accused are considered and court is inclined to find guilty U/Sec.252 Cr.P.C for the offence under sections 270, 273 IPC and Sec.20(2) of COPTA Act. The accused No.1 and 2 submitted that this is only the case involved by them and they will be careful hereinafter. Hence, prayed the court to take lenient view considering the same. Taking the plea of the accused into consideration. I am of the view that sentencing the accused to pay fine would meet the ends of justice. In the result, the Accused No.1 and 2 are found guilty for the offence under Sections 270, 273 IPC and Sec.20(2) of COTPA Act. As such, accused are convicted under section 252 Cr.P.C. The Accused are sentenced to pay a fine of Rs.1500.00 (Rupees One thousand and five hundred only) each, in default of payment of fine, the Accused shall undergo S.I for a period of 1 month for the offence under section 270 (500/- each), 273 IPC (500/- each) and Sec.20(2) of COTPA Act (500/- each). Total fine amount of Rs.3000.00. The unmarked case property i.e., 1. R.R tobacco gutka products-50 packets each one packet value of Rs.750/- total w/Rs.37,500/- shall be destroyed after lapse of appeal period. The unmarked case property i.e. Active Scooty No.AP 20 AU 8511 which was given towards interim custody vide Crl.M.P.No.543/2022, dt.12.12.2022 shall be made absolute after lapse of appeal period. Office is directed to issue receipt for payment of fine, if paid, so also to remit the fine amount to the State forthwith.
