1. These two bail applications were listed for remaining arguments today.
2. Mother & Sister of Deceased have today provided a pendrive to this Court. It is stated that the said pendrive contains some material video footages from a CCTV that was installed near the spot of incident, DVR of which has been seized by the Investigating Officer of this case.

3. The pendrive is taken on record by making an endorsement in this regard on the packaging of the pendrive.
4. At the request of Ld. Addl. PP, the videos contained in the pendrive are played in the Court and are found containing footages relevant to the present case.
5. Mother & Sister of the Deceased as well as Ld. Counsels for A-2 & A-3 submit that a copy of the videos in the pendrive be provided to them also. Heard & Allowed. The requesting parties are at liberty to collect the video footages in their own pendrives. They shall handover new sealed pendrives to the Stenographer who shall save the video footages in those & return to the requesting parties.
6. Ld. Addl. PP for the State and Ld. Counsels for A-2 & A-3 submit that in view of video footages filed today, the bail applications may be adjourned for further arguments. Ld. Addl. PP also requests that the IO be summoned for clarifications regarding video footages on the next date and the Mother & Sister of the Deceased be also directed to appear.
7. In view of the aforesaid requests, re-notify both the bail applications for arguments/further proceedings on **24.08.2026**. **IO be summoned for the said date.** Mother/Sister (or both) of the deceased shall also appear.
