

CHARGE

I, N. D. Meshram, Judicial Magistrate, F.C., Ghodegaon, Dist. Pune, hereby charge :

R/o. Avasari Khurd, Tal. Ambegaon,
Dist. Pune.

as follows :

1. That, on 13.05.2018, at about 02.00 pm, on Pune-Nashik highway at the bridge of Bypass river in the jurisdiction of village Peth, Tal. Ambegaon, Dist. Pune, you accused, drove your Force Cruiser bearing registration No. MH-14-E-9139, on a public way, in a rash and negligent manner so as to endanger to the human life of Shri. Dashrath Genbhau Gavade and his wife Sau. Manda Dashrath Gavade, and thereby committed an offence punishable U/s.279 of the IPC and within my cognizance.

2. That, on the given date, time and place, you accused, caused hurt to Honda Activa rider Shri. Dashrath Genbhau Gavade and pillion rider Smt. Manda Dashrath Gavade by giving dashed to their two wheeler Honda Activa bearing registration No. MH-14-BS-8092 by your four wheeler Force Cruiser bearing registration No. MH-14-E-9139, so as to endanger human life of Shri. Dashrath Genbhau Gavade and his wife Sau. Manda Dashrath Gavade, and thereby committed an offence punishable U/s.337 of the IPC and within my cognizance.

2. That, on the given date, time and place, you accused, caused grievous hurt to Honda Activa rider Shri. Dashrath Genbhau Gavade and pillion rider Smt. Manda Dashrath Gavade by giving dashed to their two wheeler Honda Activa bearing registration No. MH-14-BS-8092 by your four wheeler Force Cruiser bearing registration No. MH-14-E-9139, so as to endanger human life of Shri. Dashrath Genbhau Gavade and his wife Sau. Manda Dashrath Gavade, and thereby committed an offence punishable U/s.338 of the IPC and within my cognizance.

4. That, on the given date, time and place, you accused cause death of deceased Dashrath Genbhau Gavade and his wife Smt. Manda Dashrath Gavade by giving dash to the two wheeler Honda Activa bearing registration No. MH-14-BS-8092 by your four wheeler Force Cruiser bearing registration No. MH-14-E-9139, which is a driven by you in rash and negligent manner and thereby committed an offence punishable u/s.304 (A) of IPC and within my cognizance.

5. That, on the given date, time and place, you accused, by driving your

Force Cruiser bearing registration No. MH-14-E-9139, so rashly and negligently as to endanger human life of Shri. Dashrath Genbhau Gavade and his wife Smt. Manda Dashrath Gavade, caused damage of two wheeler Honda Activa bearing registration No. MH-14-BS-8092 and thereby committed an offence punishable U/s.427 of the IPC and within my cognizance.

6. That, on the given date, time and place, you accused, drove your Force Cruiser bearing registration No. MH-14-E-9139, at a speed or in a manner which is dangerous to the public having regard to all the circumstances of the case including the nature, condition and use of the place where the vehicle is driven and the amount of traffic and thereby committed an offence punishable U/s.184 of M.V. Act.

And I hereby direct that you be tried by me on the aforesaid charge.
