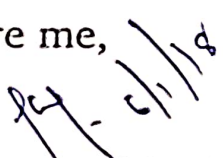

JUDGMENT ON PLEADING GUILTY

The accused has been produced in the Court today by jail Authority. The accused is an under trial prisoner against whom the charge sheet was filed on 06/01/2018. The compliance in respect of section 207 came to be undertaken by supplying the copy of the charge-sheet to the accused. Particulars of the offence came to be

framed. It came to be read over to the accused in his vernacular. He pleaded guilty to it. Apart from it the accused tendered an application and thereby contended his acceptance of guilt. On inquiry, I am satisfied that the accused has voluntarily pleaded guilty. Heard the accused on the point of sentence. He refused legal aid though offered. Heard the APP on the point of sentence. The accused submitted that he be considered sympathetically while awarding sentencing part. Taken into account the facts and circumstances involved in the present case this Courts passes the following order :

ORDER

- i) The accused is convicted u/sec. 252 of Cr. P. C. for offence punishable u/sec. 142 of Maharashtra Police Act and sentenced to suffer Simple Imprisonment for One month and to pay fine of Rs. 500/- (Rs. Five Hundred Only) in default there of to undergone further Simple Imprisonment for five days.
- ii) The period of detention, if any, undergone by the accused during investigation, inquiry or trial, be considered for the set off against the term of imprisonment imposed upon the accused.
- iii) Copy of Judgment be given to the accused free of cost.
