JUDGMENT

The accused is present before the court. Today, the accused pleaded guilty voluntarily. I am satisfied that accused pleaded guilty voluntarily. Therefore, his plea is accepted and accused is held guilty for the offence punishable under Section MVDR 4/12, 177(A) M.V. Act, 179(I) M.V. Act, MMVR 239/177 MV Act.

2- Heard accused on the point of sentence. Accused submitted that this is his first offence and they prayed for leniency. Learned APP prayed to award maximum sentence provided under the law. 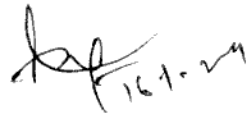
ORDER

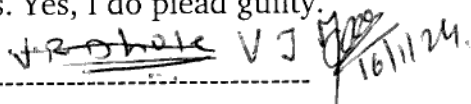
