ORDER

1. An application for grant of anticipatory bail has been filed by
applicant Kamal Kant son of Bal Krishan(hereinafter to be referred to as
bail applicant).

3. I have heard the learned counsel for bail applicant and
carefully perused the record.

4. Perusal of file reveals that Hardev Singh complainant has
filed a complaint U/S 420/406/120-B IPC against the applicant and others.

Vide order dated 16.10.2015, applicant and others have been summoned for commission of offence U/S 420/120-B IPC by the learned trial Court. Vide order dated 17.01.2018, bail applicant has been summoned through bailable warrants. The applicant was summoned in a complaint case, his guilt is yet to be proved. The presence of applicant is required before the learned trial Court. The applicant is ready to appear before the learned trial Court. In these circumstances, the applicant is ordered to be released on interim bail on his appearing before the learned trial Court and on his furnishing personal bond in the sum of Rs.40,000/- with one surety in the like amount to the satisfaction of the learned trial Court on the conditions that the applicant shall appear before the learned trial Court within 10 days from today. Copy of order along with record be sent to the Court of learned trial Court .

5. Now case is adjourned to 21.02.2018. The applicant is directed to place on record copy of order passed by the learned trial Court with regard to appear before the learned trial Court and furnish the bail bond and surety bond. Notice of bail application be also issued to complainant for date fixed.
