Issue a letter of request to Bar Council of Delhi to try and develop some kind of mechanism as this sort of confusion has arisen previously also before this Court which leads to waste of time of this Court. Meanwhile, accused be produced before this Court on the next date of hearing in order to clear the confusion of his representation. Ld. Secretary, Bar Council of Delhi is requested to apprise this Court about its request by the next date. Meanwhile, issue notice to the present and previous DCP as to what steps have been taken in order to ensure the placement of supplementary charge-sheet/ FSL result before this Court before today's of hearing. Also issue notice to the concerned MM as to what steps have been taken by him to ensure timely collection of FSL result.

Give one copy of this order-sheet to IO to obtain explanation of concerned DCP (s). Meanwhile, on his request, issue a notice to the Director FSL concerned to file the FSL result before this Court or the reasons thereof if the same is not filed before this Court before the next date of hearing.

Concerned IO is directed to supply one copy of FSL report / result to main counsel or the accused against due acknowledgement preferably before the next date of hearing.

Re-list the matter for further proceedings, as per law on 05.01.2022.
