This is an application u/s 439 CrPC moved on behalf of **applicant/accused Ravi** for grant of bail.

Reply to bail application filed.

Arguments heard. Record perused.

Ld. Additional PP for State has strongly opposed the bail application and submitted that allegations against applicant are serious in nature. That if granted bail, applicant may jump the bail or may influence the witnesses or may tamper the evidence. It is prayed that applicant may not be granted bail.

Allegations against applicant is that he severely beaten his wife Kajal and her sister Anshu with baseball bat on their head and other body parts. Further, trial is at initial stage. Moreover, public witnesses are yet to be examined. Further, allegations against applicant are grave and serious in nature. Hence, no ground to grant bail to applicant is made out at this stage. Accordingly, **bail application moved on behalf of applicant/accused Ravi stands dismissed.**
