An application has been moved for plea bargaining U/s 290
BNSS, seeking benefit by way of plea bargaining.

This Court was satisfied that the accused person has
voluntarily moved the application and understood the nature of the
accusation/ charges against him and also the nature and extend of
punishment under the law.

Parties were apprised by the Court that the entire process of
negotiation has to be worked out in a free, fair and voluntarily manner without
any force, fear, undue influence, coercion and if at any stage they or any of
them entertain any doubt, the Court be apprised of the same.

No party reported any untoward incident or use of undue
influence, fear, coercion, misrepresentation of fraud by one party or the other.

The parties have now reported that they have worked out
mutually satisfactory disposition of the case.

Separate statement of the accused persons and the IO is
recorded to this effect.

Keeping in view the statement of accused person, he is held
guilty for the offence under section 223(A) BNS.
