Examination in chief by the Spl. Public Prosecutor.

1. From 25.06.2012 to 10.07.2025 I was working as Senior Specialist at Government Hospital, Maddur.
2. On 18.12.2020 at 6.30 PM I have examined a patient by name Venkatachala S/o Chinnaiah, aged 38 years, who was brought by his relative Srinivas with a history of assault.
3. The patient himself gave me the history that he was assaulted on 18.12.2020 at about 5.30 PM near his house in Seenappanadoddi by one Puttaswamy and Mallesha.
4. On examination I found multiple linear abrasions over both upper limbs and the patient complained of pain all over his body.
5. After examination I gave intimation to the police which is now marked as **Ex.P.19** and the signature is marked as

Ex.P-19(a). On the same day at 8.40 PM CW.17 came to the hospital and recorded the statement of the Victim in my presence. Now I am shown the said statement which is already marked as Ex.P.1 and the signature is marked as **Ex.P-1(b).**

6. After examination of the Victim as per the request of Investigating Officer I have issued the wound Certificate which bears my signature and seal which is now marked as **Ex.P.20** and the signature is marked as **Ex.P-20(a).** I have also issued MLC extract, which is now shown to me is now marked as **Ex.P.21** and the signature is marked as **Ex.P-21(a).**
7. In my opinion the injury noted is simple nature. Now I am shown MO.1 knife and I am of the opinion that the injury noted above could be caused if a person is assaulted with MO.1 knife.

Cross – examination: Sri DCR Adv. for Accused:

8. At the time of recording the Ex.P.1 statement of the Victim, the Victim was conscious and oriented. At the time of recording the Ex.P. 1 statement the Victim was very comfortable. It is true to suggest that if a person falls on a sharp edged surface there are chances of causing injuries noted in the Wound Certificate. I have not mentioned the age of the injuries in the Wound Certificate. Witness volunteers that if the age of the wound is more than 6 hours the age would be mentioned in the Certificate. It is not true to suggest that the Victim did not give any history of assault

before me. It is not true to suggest that, I have noted the history as told to me by the relative who accompanied the Victim. It is not true to suggest that I am deposing false before court.
