The suit is coming for hearing on 07.02.2025 before me, in the presence of Thiru.P.Bharath, Advocate for Plaintiffs and Thiru.V.Moorthy, Advocate for the Defendants No.1 to 6 and the Defendants No.7 to 9 are remained exparte.
