J U D G M E N T

(Declared on 02/01/2025)

- 1) The accused Govind Dadarao Vithubone is alleged to have committed offence punishable under Section 12(A) of Prohibition of Gambling Act .
- 2) The accused is present today. The particulars of the offence were read over and explained to be in marathi. The accused filed application at Exh.5 and voluntarily plead guilty. I accept the plea of the accused and hold him guilty for the offence as stated above.
- 3) Heard the accused on the point of sentences. He prayed for leniency, on the ground that, he is only earning member of his family. He also submitted that he is repenting his mistake. On considering the offence and plea alongwith submission of the accused, the following order will meet the ends of justice. Hence, I pass following order;

O R D E R

- 1 The accused Govind Dadarao Vithubone is convicted for the offence p/u/Sec.12(a) of prohibition of Gambling Act Sec.252 of Cr. P.C.1973.
- 2 The accused is sentenced till rising of the Court and to pay fine of Rs.300/- (Rupees three hundred only) in default to suffer simple imprisonment of 7 days.
- 3 Seized Muddemal Rs.540/- be credited to State after appeal period is over. Other property i.e. pen, karbon paper etc being worthless, hence be destroyed after appeal period is over.
