No. MH-11, AL-5937 in a manner so rash and negligent as to endanger human life, or to be likely to cause hurt or injury to any other person and thereby you have committed an offence punishable u/s 281 of BNS and within my cognizance.

Secondly

That on the above date, time and place you drove you above mentioned vehicle in rash and negligent manner and caused hurt

to the informant son and thereby committed an offence punishable under Section 125(a) of BNS and within my cognizance.

Thirdly

That on above-mentioned date, time and place you drove your above mentioned vehicle in rash and negligent manner and caused grievous hurt to the informant son and you thereby committed an offence punishable under Section Section 125(b) of BNS and within my cognizance.

Forthly

Secondly, on the above date, time and place you committed mischief by causing damage to the motor cycle of the informant son and that you thereby committed an offence punishable under Section 324(4) of BNS and within my cognizance.

Lastly

That, on above mentioned date, time and place you drove you above mentioned vehicle in rash and negligent manner without considering the nature, traffic on road, condition and other circumstances on the road and caused incident of accident and that you thereby committed an offence punishable under Section 184 of the Motor Vehicles Act and within my cognizance.

Particulars are read over and explained to accused in vernacular to which he voluntarily pleaded guilty.

ORDER

1. Accused **Chandraprakash Rajendra Singh Alias Vinodkumar Rajendra Singh** is convicted of offence punishable under Section 281 of the BNSS and sentenced to suffer simple imprisonment till raising of Court and to pay fine of Rs. 500/- in default to suffer simple imprisonment for 5 (Five days) days vide sec. 252 of the Code of Criminal Procedure.
2. Accused above named is convicted of offence punishable under Section 125(a) of the BNNS and sentenced to suffer simple imprisonment till raising of Court and pay fine of Rs. 1000/- in default to suffer simple imprisonment for 2 (Days days) days vide sec. 252 of the Code of Criminal Procedure.

3. Accused above named is convicted of offence punishable under Section 125(b) of the BNSS and sentenced to suffer simple imprisonment till raising of Court and to pay fine of Rs. 1,000/- in default to suffer simple imprisonment for 5 (Five days) days vide sec. 252 of the Code of Criminal Procedure.
4. Accused above named is convicted of offence punishable under Section 324(4) of the BNSS and sentenced to suffer simple imprisonment till raising of Court and to pay fine of Rs. 1500/- in default to suffer simple imprisonment for 5 (five days) days vide sec. 252 of the Code of Criminal Procedure.
5. Accused above named is convicted of offence punishable under Section 184 of the Motor Vehicles Act and sentenced to suffer simple imprisonment till raising of Court and to pay fine of Rs. 300/- in default to suffer simple imprisonment for 5 (Five days) days vide sec. 252 of the Code of Criminal Procedure.
6. Copy of Judgment be given to accused free of cost.
