Seen the bail petition filed on behalf of the accused person namely, Shri Gurpreet Singh and Shri Kulwinder Singh praying to allow them to go on bail. 4. The accused Shri Gurpreet Singh and Shri Kulwinder Singh were arrested on 23/1/2026 in connection with Khatkhathi P.S case no: 10/ 2026 under Section 15(a)/17(b)/29 of NDPS Act. 5. The prosecution has alleged that on 23/1/2026, during routine Naka checking at Khatkhathi Naka Checking point, one Truck bearing Registration no: PB-65 AN/ 1277 was stopped and the said truck was searched and upon searching 4 packets of Jelly like substance suspected to be Opium weighing about 2.026 Kgs and one packet containing poppy straws weighing about 178 Grams was recovered from the truck; hence this case.

The accused Shri Gurpreet Singh is the driver and Shri Kulwinder Singh is the co-driver of the aforesaid truck; hence they were arrested. 7. The Ld. Counsel for the bail petitioner has submitted that accused Shri Gurpreet Singh and Shri Kulwinder Singh may be released on bail as investigation is nearly complete and the IO has got sufficient time to investigate the case, and that the accused would co-operate during trial. 8. The Ld. PP has submitted that there is sufficient material against the accused persons; as such to reject the prayer for bail. 9. The IO has also filed written objection stating therein to reject the prayer for bail as the accused might hamper the progress of investigation and they might abscond and that the investigation is still pending. 10. It is seen from the perusal of record that the investigation in this case is in progress, and it is near completion and only the FSL report is awaited and the CDR report.

	Continued 12/3/2026	11. It is further seen that no meaningful progress in investigation has taken place in this case since 18/2/2026. 12. It is also seen that the amount of contraband allegedly recovered from the accused persons is of intermediate quantity. 13. It is also seen that there is less likelihood that the accused could influence witnesses in this case as none of the witnesses are known to the accused and most of the witnesses are police officials and their statements are already recorded. 14. In view of the above discussions and considering the length of detention and also the fact that investigation is nearly complete, I am of the considered opinion that the further custodial detention of the above-named accused would not be necessary for completion of the investigation; hence the prayer for bail is allowed. 1. The accused, Shri Gurpreet Singh and Shri Kulwinder Singh are allowed to go on bail of Rs.
