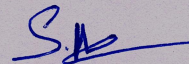
A W A R D

1. That the DHr and JDr No.3 settled the matter for Rs.2,21,720/- (Rupees Two Lakhs Twenty one thousand Seven Hundred and Twenty only)
2. The JDr No.3 paid an amount of Rs.1,37,250/- (Rupees One Lakh Thirty Seven Thousand Two Hundred and Fifty only) to the DHr out of the settled amount.
3. The JDr No.3 agreed to pay remaining balance amount of Rs.84,470/- (Rupees Eighty Four Thousand Four Hundred and Seventy only) to the DHr in (09) nine monthly equal installments i.e. Rs.9,385/- per month from January 2024, on or before 20th of every month.
4. If the JDr No.3 fails to pay the balance E.P. amount within the stipulated time, the DHr is at liberty to file fresh E.P.
5. Hence, the E.P. is settled.
6. Accordingly, Award is passed.

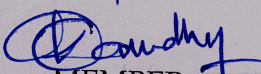

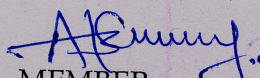


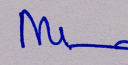
