AWARD:

The plaintiff has filed the present civil suit against the defendants to the effect that defendants have exchanged their land as per compromise and plaintiff be declared as owner in possession of land, earlier owned by defendants, comprised in Khewat No.15//15, Khatoni No.23, Khasra and killa No.123//17/2(7-12) total land measuring 7 Kanal 12 Marla as per Jambandi for year 2018-19 read with mutation No.6035 situated in Village Kungar, Tehsil Bawani Khera, District Bhiwani and further that defendants are owner in possession of the land earlier owned by plaintiff, comprised in Khewat No.18/2 Min, Khasra and Killa No.106//17/2(7-12) total land measuring 7 Kanal 12 Marla situated in Village Kungar, Tehsil Bawani Khera, District Bhiwani in

equal share as per their oral exchange and they are entitled to get incorporated their names in revenue records qua land accordingly.

2- On the other hand, defendants have appeared and filed compromise Ex.C1. Statements of both parties regarding compromise are recorded.

3- Heard. File perused. In view of compromise Ex.C1, statement of defendants regarding compromise and in view of the observation made by our own Hon'ble High Court in cases titled as **Ved Pal @ Vedu Vs. Smt. Raj Rani 2003(1) PLR-455** and **Ram Piari Vs. Shamsheer Singh and Others 2004 (3) CCC 97**, the award is hereby passed and claim of the plaintiff is allowed as prayed for. The plaintiff and defendants are hereby declared as owners of the properties as per compromise Ex.C1. The award shall be binding between the parties to the suit. Revenue entries are also liable to be corrected. The parties are left to bear their own costs. The present award shall have no effect on the unclaimed legal right of 3rd party or anything concealed from the Court. Charges shall be moved with property. File be consigned to the record room after due compliance.
