Arguments addressed by the Ld. Counsels for the parties.

Record perused.

It is submitted by the Ld. Counsel for the petitioner/complainant that the petitioner/complainant had filed five complaint cases against the respondent/accused under Section 138 of NI Act bearing CC No. 573/2022 titled as *Bajrang Dass Gupta & Sons v. Shri Balaji Enterprises & Ors.*; CC No. 670/2022 titled as *Bajrang Dass Gupta & Sons v. Sanjay Kumar*; CC No. 811/2022 titled as *Ashok Kumar v. Sanjay Kumar*; CC No. 1760/2022 titled as *Bajrang Dass Gupta & Sons v. Sanjay Kumar*; and CC No. 1761/2022 titled as *Bajrang Dass Gupta & Sons v. Sanjay Kumar* and all the five cases are being heard by the Court of Ld. JMFC (NI Act) (Digital Court)-03 (West). However, on 22.11.2025, out of the said five cases, three cases i.e. CC Nos. 573/2022, 670/2022 and 811/2022 were got transferred to the Court of Ld. JMFC-07 (West) and two cases i.e. CC Nos. 1760/2022 and 1761/2022 were got transferred to the Court of Ld. JMFC-08 (West). It is further submitted that all the above mentioned cases are required to be tried by one Court in order to avoid conflicting orders as the parties in all the cases are same and are connected cases.

Ld. Counsel for the respondent submitted that he has no objection, if the prayer made in the petition is allowed and all the cases are tried by one Court.

In view of the submissions made by the Ld. Counsel for the petitioner and no objection given by the Ld. Counsel for the respondent, and in order to avoid conflicting orders, the transfer petition is allowed. The cases bearing CC No. 1760/2022 titled as *Bajrang Dass Gupta & Sons v. Sanjay Kumar* and CC No. 1761/2022 titled as *Bajrang Dass Gupta & Sons v. Sanjay Kumar* are withdrawn from the Court of Ld. JMFC-08 (West) and the same are assigned to the Court of Ld. JMFC-07 (West), where the parties shall appear on **19.05.2026**.

Copy of this order be sent to both the concerned Courts for necessary information and compliance.
