I was working at Dominos Pizza at Rajouri Garden, New Delhi. It was Janamashtami on 06.09.2015. I am the registered owner of Pulsar Motorcycle bearing no. DL-10SE-0105. On that day, my brother Suraj and his friend Sikandar had taken my aforesaid motorcycle. Later on I came to know that my aforesaid motorcycle has been burnt. My brother Suraj later on told me that the accused persons who quarreled with Sikandar at the drain, 12 ½ gajj, burnt the motorcycle. My brother Suraj did not tell me the name of accused persons/assailants. I do not know those persons.

In that case, one Chhibbu, who was friend of my brother and Sikandar received injuries but I do not know who caused injuries to them.

At this stage, Ld. Addl PP seeks permission to cross examine the witness as he is resiling from his previous statement u/s 161 of Cr.P.C.

I was inquired upon by the police and my statement was recorded in the present case.

I did not state in my statement that at the time when my brother Suraj had taken my aforesaid motorcycle , alongwith Sikandar stated to me that his friend Naveen Saini @ Chhibbu was being beaten by Manoj Bhati, Vinod Bhati and Giriraj Bhati or that later on my brother Suraj came and told me that his friend Naveen @ Chhibbu was beaten by these persons or that they lit our aforesaid motorcycle on fire or that I alongwith uncle and mother Manisha had taken Naveen to Guru Gobind Singh hospital. Confronted with statement recorded u/s 161 of Cr.P.C, now **Mark Ex.PW3/MarkA**, where it is so recorded.

It is wrong to suggest that today I am not deposing the true facts of the case deliberately under the pressure of accused persons as me, my brother Suraj and injured of the present case have compromised the matter with the accused persons. It is wrong to suggest that I am deposing falsely.
