Ordered

That the A1 Sk. Sani @ Sk. Saniyaz Ali, is acquitted of the charge U/S 6 of the
Protection of Children from Sexual Offences Act, 2012 and Sections 363/366/506/376(3) of
Indian Penal Code and section 9 of Prohibition of Child marriage Act while the A2 Sk. Toufik
Ali, A3 Sk. Tajul Ali @ Tajuddin Ali, A4 Samina Begum and A5 Sk. Monirul are acquitted of the
charges in respect of the offences punishable under sections 363/366/506/109 of Indian Penal
Code and section 10 of Prohibition of Child marriage Act as per Section 235(1) of Cr.P.C.

Let A1 Sk. Sani @ Sk. Saniyaz Ali be released at once unless required in any other
matter.

A2 to A5 viz, Sk. Toufik Ali, Sk. Tajul Ali @ Sk. Tajuddin Ali, Samina Begum and Sk.
Monirul are discharged of their bail bonds. Sureties are discharged.

Sk. Sani @ Sk. Saniyaz Ali, Sk. Toufik Ali, Sk. Tajul Ali @ Tajuddin Ali, Samina Begum
and Sk. Monirul are directed to submit bail bonds of Rs. 500/- each with one surety of like
amount to the satisfaction of Ld. A.C.J.M, Uluberia, which shall remain in force for six months as
per Section – 437A of Cr.P.C to appear before the Higher Court as and when such Court issues
notice in respect of any appeal or petition filed against this instant judgment.

The seized articles shall be disposed in accordance with law.

Let a copy of this judgment be sent to the District Magistrate, Howrah.
