

IN THE COURT OF ADDITIONAL SESSIONS JUDGE, BEED**Criminal Bail Application No.607/2026**
(CNR No. MHBI0100-1912-2026)**Lahu s/o. Sukhdev Kusalkar****Vs.****The State of Maharashtra****ORDER BELOW EXH.1**

1] This is an application filed by the petitioner/applicant to release him on regular bail in crime No.144/2026 punishable under sections 115(2),118(2), 125, 189(2), 190, 191(2),191(3), 351(2), 352 of the BNS, 2023 and sections 3(1)(r), (s), 3(2), 3(2)(va),3 (v) of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 registered with Pimpalner Police Station.

2] Petitioner /accused submitted that there is allegations that informant has Kirana Shop. He used to do hotel business in the vicinity. Applicant and his family members harassing him to stop the hotel. On the day of incident, informant was in shop, then petitioner and his family members came there and started abusing to the informant and stated that he shall not reside in said vicinity being he is of Schedule Caste. They abused to the complainant on his caste. Petitioner also assaulted the complainant with the weapon Sattur on his head. Another co-accused the son of the petitioner Krusha assaulted by iron rod on head and beside ear. co-accused Sunil Mohite assaulted by stone. When his wife came to rescue then wife of accused assaulted her with the fist

blows. He further submitted that he is arrested on 16.06.2025. After PCR he is in MCR.

3] Petitioner submitted that he is innocent. He is falsely implicated in this case. Petitioner also filed case against the complainant. To counter blast to the said case, this false case is filed. Petitioner was arrested, recovery of wooden log is made. His further detention is not required. He is ready to abide all the terms and conditions. He is ready to co-operate in the investigation. He is ready to furnish surety. He will not tamper to the prosecution witnesses. Therefore, prayed to grant bail.

4] APP has filed say and submitted that there is prima facie case against the applicant. There is active participation of this applicant. If he is released on bail, he will pressurize the complainant. He will commit such type of offence. Therefore, prayed to reject the application.

5] Complainant also filed say and submitted that all the accused persons assaulted to the complainant with the deadly weapon like Satur, iron rod, stones therefore, he sustained injury. He submitted that if petitioner is released on bail then again his life will be in danger. He will commit such type of offence. He will pressurize the complainant and witnesses. Investigation will not be possible. Weapon is not seized from this accused. Therefore, prayed to reject the application.

6] Heard the Ld. advocate for the petitioner, Ld. Advocate for the complainant and Ld. APP for the State.

7] I have perused the record then it is gathered that accused is arrested and remanded in MCR on 19.06.2026. Considering the allegations this petitioner assaulted to the complainant with the deadly weapon like Sattur on the head of complainant. This weapon is not seized during the investigation. Only wooden log is seized. Other accused person assaulted with the iron rod. Investigation is yet to be completed. Nature of offence is serious. If petitioner is released on bail then there is possibility of further offence. Other accused persons are yet to be arrested. If accused is released on bail then he will pressurize on the complainant and witnesses. Charge-sheet is yet to be filed. Considering all these reasons at this stage, petitioner/accused is not entitled for bail. As per the medial certificate informant was sustained grievous injury and his C.T. Scan also done. Considering all these reasons, petitioner is not entitled for bail and therefore, application is liable to be rejected. Hence, following order.

ORDER

Application is hereby rejected.
