ORDER BELOW APPLICATION FOR REGISTRATION OF BIRTH

1] This is an application filed by applicant Ignatia Maria Fernandes (Maiden Name : Ignatia Maria John Monterio) with contention that she was born on 05/05/1959 at home. The applicant's mother name is Smt. Antoneitte John Monterio and father name is John Monterio.

2] The respondent i.e. Medical Officer of Health, H/West Ward, Bandra W, Mumbai has filed report and submitted that the birth of Smt. Ignatia Maria Fernandes born on 05/05/1959 to Mr. John Monterio and Mrs. Antoneitte John Monterio is not registered with this office. The said officer further submitted that to scrutinize the proposal and necessary order be passed.

3] Alongwith this application, the applicant has filed on record her affidavit stating every facts as per her application and enclosed verified copy of her Aadhaar Card, Marriage Certificate, Baptism Certificate on record. Also, the applicant has filed on record affidavits of witnesses namely Augustine Camil Gonsalves and Cecilia Philip D'Souza who on oath stated to have been present at the time of birth of the applicant. filed on record as proving of their identify and address. Also, original certificate issued by Mount Carmel Church is filed which certify with her, being born on 05/05/1959, being baptized as daughter of John and Antoinette on 08/08/1959.

4] On perusing the application, documents of the applicant in support of her application, affidavits of witnesses and report of BMC, this Court did not find any hesitation to accept that 05/05/1959 is true and correct date of birth of applicant. Hence, proceed to pass following order.

ORDER

1 The application is allowed.

2 The concern authority 'The Registrar, Birth and Death, H/West Ward, Bandra (W), Mumbai – 400 0050' is directed to take entry of the date of birth i.e. 05/05/1959 (Fifth May Nineteen Fifty Nine) of Ignatia Maria Fernandes (Maiden Name : Ignatia Maria John Monterio), in their register on accepting the fees as per rule.
