CBI V. Ram Kumar (Applicant Indu Rekha)

Present : Sh. Rohit Drall (**VC**), Ld. Counsel for applicant.

This is an application moved on behalf of applicant Indu Rekha seeking modification in the order dated 29.01.2026.

It, is inter alia, pleaded in the application that they had moved an application (Misc.DJ/ASJ-25/2026) seeking refund of fine amount of Rs.40,000/- consequent to the setting aside of the judgment of conviction as well as well as order on sentence by the Hon'ble High Court in appeal vide order dated 12.03.2025. The said application was disposed off by this Court vide its order dated 29.01.2026. However, due to typographical error, it was not clearly mentioned that the said application was moved on behalf of Ram Kumar who had already expired on 24.11.2021. Copy of the death certificate of Ram Kumar is annexed as Annexure-B. Due to the said mistake on their part, the amount of Rs.40,000/- was ordered to be released/refunded to applicant Ram Kumar.

It is further pleaded that as Ram Kumar has already expired on 24.11.2021, the aforesaid fine amount of Rs.40,000/- needs to be released/disburse in favour of Ms. Indu Rekha (wife of deceased Ram Kumar) who is the lawful claimant and legal representative of the deceased.

At the outset, Ld. Counsel for applicant has conceded that it is the mistake on their part which has resulted in filing of the present application. It is prayed that the present application be allowed in the interest of justice.

Heard and considered.

The order dated 29.01.2026 is perused.

The applicant herein is the wife of Ram Kumar (deceased), in whose favour the fine amount of Rs.40,000/- was ordered to be released vide order dated 29.01.2026. The death certificate Annexure-B reflects that Ram Kumar has already expired on 24.11.2021 and name of his wife there in the said death certificate in the Column 'Name of Spouse' as Indu Rekha.

In these circumstances, the application in hand is allowed. **The order dated 29.01.2026 is modified to the extent that the amount of fine of Rs.40,000/- be refunded to applicant herein namely Indu Rekha wife of late Ram Kumar. Reader is directed to issue fresh proper refund voucher in favour of applicant Ms. Indu Rekha wife of Ram Kumar in terms of order dated 29.01.2026.**

Accordingly, the present application (Misc.DJ/ASJ 278/2026) stands disposed off.

A copy of the order be given dasti to applicant/her counsel.
