As per the orthopedic opinion issued by the Civil Hospital Dharashiv, I had issued injury certificate. Now I shown the said certificate. It's contents are true and correct as per original MLC. register. It bears my signature and seal of the hospital. It is marked as **Exh. 43**. The injury mentioned in the MLC certificate Exh. 43 can be possible if the person hit by the iron rod.

It is not true to say that, I know the injured since long. It is true to say that, the expert opinion and X-ray is not filed on record. It is not true to say that, I had not examined
