I alongwith my family resides at the aforesaid address as a tenant. I and my father used to sell vegetable on Rehri in weekly market and in the area.

Dubloo @ Badal is my younger brother and Smt. Anju is my sister, who is already married. I am also married. I have two daughters and a son. My brother Dubloo @ Badal was working at a meat shop situated at B-1 Chowk, Tagore Garden, Delhi and he was unmarried. My brother Dubloo @ Badal was in love with a girl namely Laadli. But parents of Laadli were not agree for the marriage between Dubloo @ Badal and Laadli and they used to say that Dubloo @ Badal has to convert himself as a muslim and then only the marriage can be solemnized, for which my brother Dubloo @ Badal was not agree.

Once, mother of Laadli, her brother namely Ladla and her Mama namely Salam came at our residence and they all were saying, '*Badal ko samjha lo, nahi toh wo ho jayega jo nahi hona chahiye*'.

Once, Laadli also visited PS and she stated that she wanted to marry with Dubloo @ Badal. Even at that time, the family member of Laadli insisted for the conversion of my brother as Muslim but we refused for the same.

Thereafter, mother and brother of Laadli had taken her to Bengal. We also sent our brother to Mumbai, at the residence of our Mama namley Suresh Chauhan. My brother remained there for 20-25 days and thereafter he came back to Delhi. My brother Dubloo @ Badal told us that he was getting call of Laadli from Bengal and at her asking he visited at the native place of Laadli. My brother further informed us that he became suspicious that he had been called there under some conspiracy by the family member of Laadli, at her instance and therefore he came from Bengal.

On 30.11.2021, I and my father were selling vegetables on Rehri at weekly tuesday market at Vishnu Garden. At about 09:30-10:00 PM, my father received a call of my mother and she informed that Dubloo @ Badal had been stabbed and he was in Guru Gobind Singh hospital. My father informed these facts to me and he leaving behind his vegetable rehri in my custody went to Guru Govind Singh hospital. After sometime I received a call from my father and he informed me that my brother Dubloo @ Badal has been shifted to Safdarjung hospital and I was asked to reach there. Firstly, I went at my residence and I left the vegetables and the Rehri there and I reached Safdarjung hospital. At Safdarjung hospital, I noticed that my brother Dubloo @ Badal received stab injury on his neck. Later on my brother was declared dead by the doctor during the course of treatment.
