

**GR No - 401/24, CIS No - 1075/25.**

**Order No. 59 dated. 15.07.25**

Accused persons namely 1. Sanjit Kumar Das 2. Bikash Kumar 3. Vikash Sahani & 4. Vijay Kumar Sah @ Bijay Sah on bail are present by filing hazira.

Accd persons namely Santosh Kumar Singh @ Bablu is produced from BDCH & Accd persons namely 1. Sanjoy Ravidas & 2. Rajkumar Goswami are produced from Dum Dum Central Correctional Home through VC and remanded to J/C till 28.07.25.

Bail petition is filed on behalf of the accd persons namely 1. Santosh Kumar Singh @ Bablu 2. Sanjoy Ravidas & 3. Rajkumar Goswami.

Since the case is Session triable the bail petition of the above three accd persons are rejected.

Accused person namely Abhishek Kumar is still absconding.

No E/R of W/P/A is received in spite of several taggid.

This case is year of 2024. No chance of execution of W/P/A.

Hence this case is declared filed for present against accd person namely Abhishek Kumar at this stage.

O/C Sariwahat PS, Dumka is directed to produce the accd namely Abhishek Kumar if arrested accd be produced before the Ld. Session Judge, Bankura on **28.07.2025.**

Copy is ready and supplied to all the accd persons on CB and JC accd persons.

Charge-sheet has been submitted against 08 accused persons.

The learned A.P.P for the State is also present.

Now, the record is taken up for commitment.

The accused persons are taken into custody on CB.

Copy has been served on the accused persons, complying the provision of Section 207 of Cr.PC.

Charge sheet has been submitted and cognizance has been taken against accused persons for offence punishable **U/S-392/397/201/411/120B IPC** from the nature of the offence, it appears that the same are exclusively triable by the Court of Session. Hence, the record be committed to the Court of the learned Session Judge at Bankura for trial U/S- 209 of Cr.PC, complying the provision of Section 207 of Cr.PC .

The petition praying for keeping the accused persons namely 1. Sanjit Kumar Das 2. Bikash Kumar 3. Vikash Sahani & 4. Vijay Kumar Sah @ Bijay Sah on same bail is taken up for hearing.

Heard both sides. Considered.

The prayer is allowed.

The accused persons who are already on bail are allowed to remain on same bail, subject to the confirmation by the Ld. Session Judge, Bankura.

Supdt of B.D.C.H, Bankura & Supdt. of Dum Dum Central Correctional Home are directed to produce the accd persons namely 1. Santosh Kumar Singh @ Bablu 2. Sanjoy Ravidas & 3. Rajkumar Goswami before the Court of the Ld. Session Judge, Bankura on **28.07.25.**

All the accused persons on CB are directed to be present before the Court of the Ld. Session Judge, Bankura on **28.07.2025** positively.
