**JUDGMENT**

1. The applicant has preferred this application seeking modification of bail condition u/s 483(1)(B) of B.N.S.S.
2. Ld. Advocate Ms.P.B.Rathod appearing on behalf of Mr.R.B.Parekh for the applicant submits that in connection

with offence registered vide I C.R.No.02/2025 with ATS Police Station for the offence under Section 336(2), 337, 338, 339, 341(2)(4), 54, 61(1)(a, b)(2)(a) of The Bharatiya Nyaya Sanhita and Section 25(1-b) (a), 27, 29, 30 of The Arms Act the applicant has been granted regular bail by this Hon'ble Court vide judgment in Cri. Misc.Appl. No. 2812/2025 dated 02/09/2025 with certain conditions including condition No.(b) as under.

*“(b) applicant/accused shall not leave local limits of State of Gujarat without prior permission of the Court;”*

- 2.1 It is stated that applicant has to frequently go outside Gujarat for business purpose. If the applicant is not allowed to go outside Gujarat then he is likely to face loss in his business. Chargesheet has been filed in the present case vide CC No.40135/2025. Applicant is residing at the address mentioned in cause title of application and is not likely to flee or abscond. Applicant has regularly remained present before the Hon'ble Court. The applicant is ready to abide by any stringent conditions that may be imposed upon the applicant while granting the present application. It is accordingly urged to allow the present application.
3. Ld. Public Prosecutor Mr.P.M.Trivedi appearing on behalf of the Opponent - State has opposed the grant of present application. He had filed report of I.O. vide Exh.9. He submits that there is prima facie case against the applicant. It is submitted that it seems that applicant is wishing to leave the State of Gujarat before the conclusion of

investigation and/or trial, on the pretext of business activities. He submits that if the present application is granted, it may hinder the proceedings and/or investigation and/or trial of the present case. There is every possibility that applicant may flee or abscond and will not remain present before the Hon'ble Court, if the present application is allowed. Ld. Public Prosecutor has placed reliance on report (Exh.9) filed by the I.O. and has urged to reject the application.

4. Heard Ld. Advocates of the respective parties. This Court has gone through the application, documents annexed to it and report of I.O. (Exh.9). This application is preferred by the applicant for modification of bail condition. It appears that applicant was granted regular bail by this Court vide order dated 02/09/2025 passed in CRMA No.2812/2025 with certain conditions including condition no.(b) that *“(b) applicant/accused shall not leave local limits of State of Gujarat without prior permission of the Court;”* As per the applicant, he is required to travel out of Gujarat for his business purpose time and again and has to suffer business loss as he could not travel out of Gujarat on account of the said condition No."(b)". It is further stated that he is regularly remaining present in the Court during trial. Prosecution has not brought anything on record about applicant having breached any of the bail conditions imposed by this Court. It is stated by the applicant that he will abide by the conditions that may be imposed by this Court on account of permission to him to travel out of

Gujarat. In view of facts and circumstances stated herein above, the case of the applicant deserves consideration and accordingly, following order is passed in the interest of justice:

**ORDER**

1. The application is allowed.
2. Condition no.(b) of the order dated 02/09/2025 recorded below CRMA No.2812/2025 passed by this Court stands modified as under:

*"(b)" applicant/accused shall not leave India without prior permission of the Court;"*
