ORDER BELOW EXH.1.

1. Present Appeal has been preferred by the appellant against the judgment and order passed in Criminal Case No. 160/2019 passed by the learned Trial Court vide order dated 09/04/2024. Thereafter, both the parties and their Ld. Advocates also remained present before this Court and the original complainant that is the opponent No. 2 herein this case has stated that the matter has been settled and he wants to get the matter dispose of in the Lok Adalat, the present appeal has been placed today before this Lok Adalat.

The appellant and the respondents have jointly filed a compromise purshis Exh. 17 stating therein that they have amicably settled the dispute between them and now, there is no dispute between the parties. The said purshis has been duly signed by both the parties and Ld. Advocate for the parties are also present. It is submitted by the parties that the matter should be referred to Lok-adalat. Hence, considering the compromise entered upon between the parties, the present appeal is required to be disposed of as per "Compromise" with a condition to quash and set aside the order passed in the aforesaid Criminal Case.

In view of the facts and circumstances of the present case and considering the pursis as the matter has been settled amicably between the parties and it is permissible in law, the present Criminal Appeal is ordered to be disposed of accordingly as "Compromise" and the judgment delivered by the learned Trial Court vide order dated 09/04/2024, is hereby ordered to be quashed and set aside.
