COMMITMENT ORDER:-

1. The above named accused have been sent up by the SHO,
Police Station, Goindwal Sahib in this Court to face trial in the above noted
case.
2. The brief facts of the present case of the prosecution are that on
01.04.2021 ASI Lakhwinder Singh alongwith other police official was

present at Adda Khan Chapri, where he received telephonic information to the effect that ASI Narinderpal Singh alongwith police party when to arrest Bhupinder Singh who has been declared “Proclaimed Person” and his family members are creating hindrance in the proceedings. That ASI Lakhwinder Singh alongwith police officials reached at the spot where ASI Narinderpal Singh got recorded his statement to the effect that he received information that Bhupinder Singh who has been declared “Proclaimed Person” in case FIR no. 39 dated 23.04.2018 Under Section 365, 342, 323, 376-D, 506 IPC P.S. Goindwal Sahib and his family members have kept him in their house and if the raid is conducted he can be apprehended. That ASI Lakhwinder Singh then reached near the spot and then they saw a person coming out from the street whom the officials apprehended and thereafter he started shouting and then 8-10 unknown family members gathered their and started fighting with the police officials during which they tore the uniform constable Gursahib Singh and also inflicted injury to HC Pargat Singh and they also interfere in the police proceedings. That family members were successful in making Bhupinder Singh ran away from the spot. Action be taken against the accused. From the statement of complainant present F.I.R was registered. Statements of witnesses were recorded under section 161 of Cr.P.C. Accused persons were arrested during investigation.

3. From the perusal of the report under Section 173 of Cr.P.C. and the documents attached thereto, it appears that the accused has committed an offence punishable under Section 323/332/186/202/212/216/148/149/224/225/353 IPC, removed Section 333 IPC, added Section 379-B(2) IPC, vide rapat no. 31 dated 28.05.2021, P.S. Goindwal Sahib which is exclusively triable by the Court of Sessions.

4. Copies of challan report u/s 173(2) Cr.P.C has been supplied to the accused free of costs u/s 207 Cr.P.C in the Court.

5. The Ld. A.P.P. for the State and the Ld. counsel for the accused have been heard and the file of the case has been perused.

6. Keeping in view the above said discussion, the present case is hereby committed to the Court of Ld. Sessions Judge, Tarn Taran, for 11.09.2023. The accused person on bail is directed to appear before the Court of Ld. Sessions Judge, Tarn Taran on 11.09.2023 at 10:00 a.m. sharp. The Ld. A.P.P. for the State has been informed in this regard. Concerned Ahlmad of this Court is directed to complete the file in all respects and to send the same to the said Ld. Court well before the date fixed.
