::O R D E R::

1. The applicant has preferred the present application for getting permission to renew the passport for 10 years.
2. Heard the Ld. Advocate appearing on behalf of the applicant and the Ld. Public Prosecutor appeared on behalf of the State.
3. The Ld. Advocate for the applicant has vehemently argued that the applicant has been enlarged on regular bail in connection

with the C. R. No.69/2016 registered with Bavla Police Station for the offences punishable U/s 395, 397, 506(2) & 120B of the Indian Penal Code by the Hon'ble High Court of Gujarat vide order passed in Cri. Misc. Application No.30352/2017 with certain conditions. It is further submitted that applicant is having one Passport bearing **Passport No.F4753336** which was issued on dated 01.09.2005 and the validity of the passport has expired on dated 31.08.2015 and hence, filed the present application to get the permission for renewal of the passport as the period of renewal of the passport has also expired and therefore, the order of the Hon'ble Court is required. It is further submitted that as per the rules & regulations of the Passport Authority, if any person having passport is facing trial of any case, the permission of the renewal period is necessary from the Hon'ble Court and if the Hon'ble Court is not mentioned the renewal period of passport, the passport authority will renew the passport for the period of only one year and therefore, the applicant has filed the present application to get the permission of the Hon'ble Court to renew his passport for 10 years. The Ld. advocate for the applicant has relied upon the judgments of the Hon'ble High Court of Gujarat passed in case of R/Special Civil Application No.3289 of 2025 dated 17.03.2025 and R/Special Civil Application No.3460 of 2025 dated 01.05.2025 and further argued that the Hon'ble High Court Gujarat has permitted the applicant to get renew his passport for 10 years and therefore, the Ld. advocate for the applicant has prayed to allow the present application with a permission to renew his passport for 10 years.

4. *Per-contra*, the Ld. Public Prosecutor for the State has submitted to pass appropriate order as per the provisions of Law.
5. I have gone through the application, records and documentary evidence produced on record and also considered the arguments advance by Ld. Advocates for the rival parties. It prima-facie appears from the record that the applicant has been enlarged on regular bail in connection with the C. R. No.69/2016 registered with Bavla Police Station for the offences punishable U/s 395, 397, 506(2) & 120B of the Indian Penal Code by the Hon'ble High Court of Gujarat vide order passed in Cri. Misc. Application No.30352/2017 with certain conditions. It is further prima-facie appears that applicant is having one Passport bearing Passport No.F4753336 which was issued on dated 01.09.2005 and the validity of the passport has expired on dated 31.08.2015 and the applicant has approached before this court to direct the passport authority to renew his passport for the 10 years. Further, it prima-facie appears from the record that the said passport is retained with the applicant. The Ld. advocate for the applicant has filed a pursis vide Exh.4 stating therein that if the passport of the applicant may be renewed for the limited period of 4 months, he has no objection. Thus, considering the facts and circumstances of the subject matter, this Court is of the opinion that permission may be granted for renewal of Passport with certain conditions, it would meet with the justice and therefore, following order is passed in the interest of justice.

: - O R D E R - :

- The present Cri. Misc. Application **No.31 of 2026** is hereby, **partly allowed.**
- The applicant-**Ajay S/o Ashok Mohite** is hereby permitted to get his passport renewed as per the prevailing norms. The Regional Passport Authority may renew the existing passport of the applicant for a period provided by law if there is no other legal impediments.
- It is clarified that the applicant shall not use either old or renewed/fresh passport for travelling abroad and if the applicant wants to travel abroad, he will have to file separate application to get the permission for travelling abroad before the concerned Court.
- The applicant shall not use either old or renewed/fresh passport for travelling abroad.
- The applicant shall not misuse the liberty.
- Yadi be made to the concerned authorities accordingly.
