On behalf of accused, learned counsel submitted that earlier no regular or anticipatory bail petition has been filed either before the court or before any higher court. The cognizance has been taken against the petitioner u/s 179 (1), 181, 184, 190 (2), 194 (B), 199(A) of M.V.Act. The alleged sections are bailable and petitioner is ready to furnish bail bond with local sureties to the satisfaction of the court. So he may be enlarged on bail. It is obvious from the case record that after submission of prosecution report, cognizance was also taken against this very accused for the offences u/s 179 (1), 181, 184, 190 (2), 194 (B), 199(A) of M.V.Act but the prosecution report does not disclose about the driving of the said vehicle on the date of occurrence nor it was disclosed in the said prosecution report that the said vehicle was driving by a child, who is the
