SUBSTANCE OF ACCUSATION
 (CHAPTER XX OF THE CODE OF THE CRIMINAL PROCEDURE)

I, Akshi Jain, Judicial Magistrate First Class, 61st Court, Kurla, Mumbai, hereby charge you.

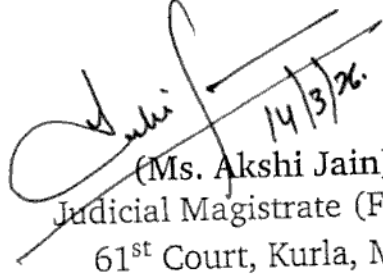
Accused - Sachin Vasant Rahate

Firstly, that on 23/02/26, at about 00,30 hours, at Kovandi Mumbai, you accused drove your Motor cycle bearing No. MH03DM7127 wrong direction on public way in such a manner so rash or negligent as to endanger human life and you have thereby committed an offense punishable under Section 281 of the Bhartiya Nyaya Sanhita and within my cognizance.

Secondly, that on the above date, time and place, you drove your Motor cycle bearing No. MH03DM7127, so rashly and negligently as to endanger human life or the personal safety of others and thereby committed an offence punishable under Section 125 of Bhartiya Nyaya Sanhita and within my cognizance.

Thirdly, that on the above date, time and place, you drove your Motor cycle bearing No. MH03DM7127, under the influence of alcohol exceeding 86.1/100 mL of blood detected by test by a breath analyzer and was under the influence of alcohol to such and extent to incapable of exercising proper control over your vehicle and thereby committed an offence punishable under Section 185 of Motor Vehicle Act and within my cognizance.

And I hereby direct that you be tried by the said Court on the said Charge.

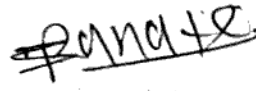

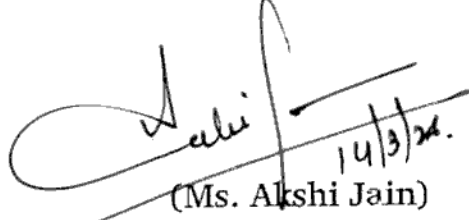
JUDGMENT

1. The accused stands charge-sheeted for the offense punishable under Section 281, 125 of B.N.S. read with 185 of Motor Vehicle Act.
2. Today the accused is present. The plea of the accused is recorded. He prayed for leniency. As per his submission and considering the facts and circumstances of the case, fine will be proper punishable to him. Therefore, following order is passed:-

ORDER

1. The accused Sachin vasant Rabate is hereby convicted for the offence punishable under Section 281, 125 of B.N.S. read with 185 of Motor Vehicle Act vide under section 275 of the Bharatiya Nagarik Suraksha Sanhita.
2. Accused is sentenced to pay a fine of Rs. 500/- and in default to suffer 03 days Simple Imprisonment for the offence punishable under section 281 of B.N.S.
3. Accused is sentenced to pay a fine of Rs. 500/- and in default to suffer 03 days Simple Imprisonment for the offence punishable under section 125 of B.N.S.
4. Accused is sentenced to pay a fine of Rs. 10,000/- and in default to suffer 14 days Simple Imprisonment for the offence punishable under section 185 of Motor Vehicle Act.

5. The bail bonds of the accused, if any, shall stand cancelled.
