:: J U D G M E N T ::

1. The facts of the application are as under.
2. That Vishalkumar Vimananchandra Jain, resident of, Ankleshwar, Bharuch was died on 28/05/2025 at Nadiyad. That applicant No. 01 is wife of decease whereas applicant Nos. 2 & 3 are are son and

daughter of deceased Vishalkumar. That applicant No. 01 is a Guardian of applicant No. 03.

3. The applicants have been filed this application to get Succession Certificate for the movable property of deceased. That deceased Vishalkumar Jain had demat account vide No. DP ID : IN303028 having its client ID 57148209 in ICICI Bank Ltd. The holding value according to statement of said account as on 09/07/2025, was of Rs. 98,78,683.39/-. The applicants have also produced copy of account statement along with present application. It is further submitted by applicants, that they are direct line heirs of deceased Vishalkumar Jain, hence the present application have been filed by applicants seeking succession certificate.

6. The publication in daily News Paper "Madhya Gujarat" dated 13/09/2025 was announced and copy of it is produced at Mark 5/1, but none has raised objection.
7. Considering the materials on record, I have sufficient reason to believe that the death of deceased Vishalkumar Vimalchandra Jain was happened on 28/05/2025 and till the date of pronouncement of the notice, no any person has challenged the application and looking in the records, affidavits and arguments, I have sufficient reason to believe that applicants are legal heirs of deceased and other legal heirs have no any objection against this application and they have free "Will" for issuing the share certificate in name of applicant No. 01, hence I am of the opinion that Applicants are entitled for 'Succession Certificate' in respect of movable property as prayed for, hence I came to the conclusion that this matter is meeting with an end of justice, therefore I pass following order.

:: ORDER ::

1. The application of applicants are hereby allowed.
2. Succession certificate be issued in favour of the applicant No. 01 in respect of the movable property of deceased husband Vishalkumar Vimalchandra Jain as described in the application

on production of requisite court fee stamps calculating the market value of the movable properties.

3. The applicant shall have right, title or interest over the scheduled property only on issuance of Succession certificate, typed on requisite court fee stamps.
4. This order will be operative only on issuance of Succession Certificate, typed on requisite court fee stamps.
