State Vs. Rajeev Khanna**

**This is bail application under Section 482 BNSS (438 Cr.P.C) moved on behalf of applicant/accused Rajesh Khanna seeking anticipatory bail.**

Fresh status report filed by the IO.

It is submitted by the IO that initially applicant/accused Rajeev Khanna joined investigation on 29.07.2025, however, he left the premises stating that the co-accused Rajesh Khanna has fainted and he would join the investigation next day. Also that, the applicant/accused was directed to join investigation on 30.07.2025, wherein he failed to do so.

Ld. Counsel for the applicant/accused submits that applicant Rajeev Khanna has joined investigation on 29.07.2025, and has filed photographs in respect of 30.07.2025, it is submitted by Ld. Counsel for the applicant/accused that applicant/ accused Rajeev Khanna has not been served with any notice to join investigation on the said dated.

IO submits that he has whatsapp conversation between him and the applicant/accused, wherein he has duly stated that he will join investigation on 30.07.2025, but he failed to do so.

Ld. Counsel for the applicant/accused submits that the applicant/accused is willing to join the investigation at 4.00 P.M. today itself.

Heard. In view of the facts and circumstances and the undertaking given by Ld. Counsel for the applicant/accused as well as the convenience of IO, the applicant/accused is directed to join the further investigation today itself at 4.00 P.M.

Thereafter, IO is directed to file a fresh status report of the investigation carried out and specific role of the applicant/accused on the NDOH. **Till then no coercive action be taken against the accused.**

At this stage, it is submitted by Id. Counsel for the complainant submits that an FIR bearing no. 39 dated 29.03.2023 PS City Navanshahar u/s 307/506/452/34 IPC and 25 Arms Act has also been lodged against applicant/accused.

IO is directed to verify the said fact and file his report of further investigation on the NDOH.

Copy of this order be given dasti to IO as well as to both the parties.
