J U D G M E N T

1. Present applicant has filed present application under Section 24 of C.P.C. to transfer M.A.C.P. No. 10/2018 pending in the M.A.C. Tribunal (Auxi.), Court of learned 7th Additional District Judge, Deesa to the M.A.C. Tribunal (Auxi.), Court of learned 4th Additional District Judge, Deesa for trial alongwith M.A.C.P. Nos. 18/2017, 9/2018, & 11/2018.
2. Notice was issued. L.A. Mr. D. K. Thakor, appearing for the opponent No.4 has filed a Pursis at Exh.5 declaring that he has no objection if M.A.C.P. No.10/2018 pending in the M.A.C. Tribunal (Auxi.), Court of learned 7th Additional District Judge, Deesa is transferred to the M.A.C. Tribunal (Auxi.), Court of learned 4th Additional District Judge, Deesa.
3. Having heard both the sides and upon going through the contents of the application and documentary evidence available on record at Mark 4/1 to 4/4, it appears that M.A.C.P.
