

**MAC Miscellaneous Application No.101/2026**

**Order below Ex.1 :**

01. The petitioners have submitted that they are original claimants in the MACP No.336 of 2012 and they have preferred claim petition against the opponents and the same was decided in favour of claimants by the M.A.C. Tribunal (Auxi.), Bhavnagar.

02. Being aggrieved and dissatisfied with the said judgment and award, claimants had preferred R/First Appeal No.4121 of 2021, before the Hon'ble High Court of Gujarat, in which the Hon'ble High Court of Gujarat had passed the following order on dated 13.12.2025 :

"..... 5. Since the appeal is disposed of, the awarded amount, if any, lying with the Bank in the form of FDRs, lying either with the Tribunal or with the Nazir Branch of the Tribunal/Court, including the enhance amount, that may be deposited by the respondent - Insurance Company, shall be disbursed in favour of the original claimant/s, after due verification and after following proper procedure, by way of an Account Payee Cheque and/or NEFT and/or RTGS. The apportionment of the awarded amount, if any, shall be in the very terms, as ordered by the Tribunal in the original award.

6. In view of above, the present First Appeal is disposed of.

7. Accordingly, Civil Application/s, pending if any, would not survive and is disposed of.

8. Record and Proceedings, if any, shall be

remitted back to the concerned jurisdictional Tribunal, forthwith."

03. It is submitted that **as per report of the Nazir, District Court, Bhavnagar, the amount of Rs.8,25,000/- and Rs.64,939/-** are lying with the Nazir, District Court, Bhavnagar.
04. It is further submitted that the other side have also made endorsement as "**No Objection**" if the present application is granted and the compensation amount be paid to the applicants.
05. Looking to the facts and documents available on record, it clearly transpires that claimants have preferred R/First Appeal No.4121 of 2021, before the Hon'ble High Court of Gujarat, which has been settled in Lok-Adalat on 13.12.2025. In support of application, the applicants have produced copies of award of MACP No.336/2012, order of Hon'ble Gujarat High Court passed in R/First Appeal No.4121 of 2021 dated 13.12.2025, adhar card of applicant No.1, PAN Card of applicant No.1, adhar card of applicant No.2, PAN Card of applicant No.2, joint bank passbook of applicants, notice, etc. at mark 3/1 to 3/8. All these documents corroborate the say of the petitioners herein. Therefore, the petitioners are entitled to receive the compensation amount. Hence, I pass following final order :-

**FINAL ORDER**

The present application is hereby allowed.

The **Nazir, District Court, Bhavnagar**, is hereby ordered to disburse and release the entire amount of **Rs.8,25,000/-** along with interest accrued thereon, if any in favour of the petitioners by way of NEFT/RTGS mode, after due verification.

The **Nazir, District Court, Bhavnagar**, is hereby ordered to disburse and release the entire amount of **Rs.64,939/-** along with interest accrued thereon, if any in favour of the petitioners by way of account payee cheque, after due verification.

Yadi be sent to the Nazir, District Court, Bhavnagar.

Necessary Payment Order be made accordingly.
