

MAC Miscellaneous Application No.231/2026

Order below Ex.1 :

01. The present application is preferred by the applicants to withdraw the awarded amount deposited before the Tribunal by other side in **original claim petition No.280/2003**.

02. Being aggrieved and dissatisfied with the said judgment and award, opponent - GSRTC had preferred **R/First Appeal No.4094 of 2018**, before the Hon'ble High Court of Gujarat has passed the following conciliation order on dated 14.03.2026.

".....4. Since the appeal is withdrawn, the award amount, if any, lying with the bank in the form of FDs/ lying either with the Tribunal or with the Nazir Branch of the Tribunal may be disbursed in favour of the claimant/s after due verification by way of RTGS....."

03. I have gone through the contents of the application. I have also gone through the order dated 14.03.2026 of the Hon'ble Gujarat High Court.

04. It is further submitted that **as per the report of the Nazir, District Court, Bhavnagar, Fixed Deposit of (1) Rs.2,38,577/- in the name of Vimlaben Valjibhai Borda, (2) Rs.39,762/- in the name of Akash Valjibhai Borda, (3) Rs.39,763/- in the name of Ashaben Valjibhai Borda, (4) Rs.39,763/- in the name of Payalben Valjibhai Borda, (5) Rs.39,763/- in the name of Rinaben Valjibhai Borda**, lying with the custody of Nazir, District Court, Bhavnagar.

05. It is further submitted that the other side has also made endorsement as **"No Objection"** if the present application is granted and the compensation amount be paid to the applicants as per order passed by the Hon'ble High Court of Gujarat.
06. In view of the foregoing discussion, the amount deposited with the Tribunal is required to be paid to the concerned applicant/s as directed in order **dated 14.03.2026 passed in R/First Appeal No.4094/2018** by the Hon'ble Gujarat High Court. Hence, I pass following final order :-

FINAL ORDER

- The present application is hereby allowed.
- The Nazir, District Court, Bhavnagar, is hereby directed to hand over the original FDR **(1) Rs.2,38,577/- in the name of Vimlaben Valjibhai Borda, (2) Rs.39,762/- in the name of Akash Valjibhai Borda, (3) Rs.39,763/- in the name of Ashaben Valjibhai Borda, (4) Rs.39,763/- in the name of Payalben Valjibhai Borda, (5) Rs.39,763/- in the name of Rinaben Valjibhai Borda,** to the concerned applicant/s lying with it, after due verification.
- The **Concerned Bank Manager, Indian Bank, Kalubha Branch, Bhavnagar,** is hereby directed to release the amount of **FDRs** alongwith an interest accrued thereon, if any, as per rules and regulation of the Bank to the petitioner/s, after due verification.

- Yadi be sent to the concerned Bank as well as Nazir, District Court, Bhavnagar.
