BHAJAN SINGH VS STATE OF PUNJAB THROUGH THE LAND
ACQUISITION COLLECTOR ETC.

Mr. Maninder Badwal Advocate for the respondent No.2.

Reply to the application for correction in the name of the claimant No.4 as “Parminder Singh @ Parvinder Singh S/o Gurnam Singh” instead of “Bhupinder Singh S/o Gurnam Singh” has not been filed today. However, Mr. Maninder Badwal Advocate for the respondent No.2 has come present and has made a statement in writing whereby he has stated that he has no objection if the application dated 27.09.2019 for correction of the name of the claimant No.4 may be allowed as per the statement under Section 19 of Land Acquisition Act and the details of payment and disbursal, which are already exhibited as Ex.R3 and Ex.R12 respectively.

Learned Government Pleader for the State/respondent No.1 has also stated at bar that he has no objection if the present application dated 27.09.2019 for correction of the name of the claimant No.4 may be allowed.

Heard on the present application.

In view of the above, the present application is hereby allowed on the basis of grounds mentioned therein and the name of the claimant No.4 is ordered to be corrected as Parminder Singh @ Parvinder Singh S/o Gurnam Singh instead of Bhupinder Singh S/o of Gurnam Singh. The Reader of this Court is directed to make necessary corrections in red ink wherever required.

Mr. Sher Singh Rathore, Advocate for the claimants has also made a statement in writing whereby he has tendered into rebuttal evidence the copy of Judgment dated 25.05.2022 titled as “Devki Nandan and others Vs. State of Punjab” as Ex.P9 and the copy of Judgment dated 31.10.2022 titled as “Rupinder Singh and another Vs. State of Punjab” as Ex.P10. He has also closed the rebuttal evidence in this case.

The perusal of the file reveals that the applications i.e. application under Order 11 Rule 1 & 2 read with Section 151 CPC and the application under Order 12 Rule 2 read with Section 151 CPC have not been registered as interim applications till today. Same be registered as interim applications.

Heard on the application under Order 11 Rule 1 & 2 read with Section 151 CPC.

Vide separate detailed order of even date, the present application under Order 11 Rule 1 & 2 read with Section 151 CPC is hereby dismissed as stated therein. Papers be tagged with the main case file.

Heard on the application under Order 12 Rule 2 read with Section 151 CPC.

Vide separate detailed order of even date, the present application under Order 12 Rule 2 read with Section 151 CPC is hereby dismissed as stated therein. Papers be tagged with the main case file.

Arguments have been heard on the main petition.

Vide separate detailed judgment of even date, the present

petition is hereby allowed, as stated therein. Memo of costs be prepared.

As this petition has been finally disposed of, therefore, all other pending applications, if any, in this petition have become infructuous and therefore, the same are hereby dismissed as such. File be consigned to the record room.
