J U D G M E N T

1. This application is filed by the Ld. Advocate for the applicant for seeking permission to sign documents during the period of his custody. The applicant was arrested on 23/09/2025 in connection with the first information report bearing part-A C.R. No. 11198030250262/ 2025 registered with Mota Khutvada Police Station, Dist. Bhavnagar for the offences punishable under Section 64 (2) (F) (I), 75, 78 of the B.N.S. and u/s.4,6 and 12 of the POCSO Act.
2. Heard learned advocate of the applicant perused the application and documents placed on record. I have also heard learned Additional Public Prosecutor for the State of Gujarat.

3. Ld. Advocate for the applicant has submitted that the applicant had obtained Gold loan from the ICICI Bank, Mahuva and during the subsistence of the aforesaid load, the applicant came to be arrested and is presently in judicial custody. It is further submitted that the said loan has already repaid by the family members of the applicant. Now, the applicant intend to obtain his signature in the documents of ICICI bank for releasing the ornaments in certain necessary forms. Therefore, it is requested to to grant permission to the applicant to sign the above documents in the presence of the concerned Jail Authority.
4. Onsidering the submission made by the Ld. Advocate for the applicant/accused and looking to the facts and circumstances of the case, present application deserves consideration. Hence I pass the following final order.

- The applicant is hereby permitted to sign the necessary documents/forms as may be required, before the concerned Jailer in accordance with law and subject to necessary verification by the concerned Jail Authority, if required.
