Subject : - Application for releasing the amount of compensation invested in F.D.R on its maturity

JUDGMENT

1. The present applicants are the heirs Original claimant i.e. Rajubhai Savjibhai Chauhan of MACP No. 634 of 2015 who is died on 29/10/2021. Therefore They have filed this application for releasing the amount of compensation invested in FDRs with Saurashtra Gramin Bank, Bhavnagar in the name of original claimant Rajubhai Savjibhai Chauhan which is already been matured on 20/02/2024. So amount of F.D.R. which is invested in the name of original claimant i.e. deceased Rajubhai Savjibhai Chauhan who is died on 29/10/2021. Therefore, present applicants prayed to pay the amount of FDR which came on their share.
2. Heard the Ld. advocate of the applicant. Read the present application. In support of this application, the applicant has produced the list of documents vide Exh.5. I have also perused the documents produced along with this

application. As per mark 5/2 death certificate, of the mother of present applicants i.e. Rajubhai Savjibhai Chauhan who died on 29/10/2021.

3. On perusal of the record, it appears that M.A.C.P. No.634/2015 was filed before the Ld. MAC Tribunal by the claimant i.e. Rajubhai Savjibhai Chauhan who is died on 29/10/2021. Further it transpires from the record that the said FDR is already been matured on 20/02/2024. The applicant have produced the copy of said FDR vide mark 5/1 and the F.D.R. is in the name of original claimant i.e. Rajubhai Savjibhai Chauhan. Further as per the death certificate produced vide Exh. 5/2 original claimant i.e. Rajubhai Savjibhai Chauhan died on 29/10/2021. Applicants have also produced pedigree of deceased. Therefore, applicants have prayed that the amount of F.D.R. which is invested in the name of deceased Rajubhai Savjibhai Chauhan be given to present applicants. Looking to the record, applicant is legal heir of deceased Rajubhai Savjibhai Chauhan. So amount of the F.D.R. which is in the name of deceased is required to be paid to the present applicants.
4. Now looking to copy of FDR produced vide mark 5/1 in the name of original claimant i.e. deceased Rajubhai Savjibhai Chauhan vide SGB/TDR No 284142 for the amount of Rs.3,03,330/- (Rupees Three lakh three thousand Three hundred Thirty only) which was issued on 20/02/2019 for 5 years thus it seems that said F.D.R. has already been matured on 20/02/2024. Thus, considering the facts and circumstances of this application, I am of the

view that the amount of compensation of deceased applicant invested in FDR in Saurashtra Gramin Bank, Bhavnagar which is already matured on 20/02/2024 be paid to present applicant herein along with interest, if any, accrued thereon. Thus, this application is allowed and I pass the following order:-

ORDER

1. The present application is hereby allowed.
2. The amount i.e. Rs.3,03,330/- (Rupees Three lakh three thousand Three hundred Thirty only) which is invested in the fixed deposit with Saurashtra Bank, Bhavnagar vide SGB/TDR No. 284142 in the name of original applicant i.e. Mr. Rajubhai Savjibhai Chohan which is already been matured on 20/02/2024 is hereby ordered to be released along with interest, if any, accrued thereon and be paid to present applicants equally after due and proper verification.
4. Intimation of this order be sent to the concerned Bank for information and necessary action as well as to the Nazir of this Court.
