

**Order below Exhibit - 1**

1. The claimants have filed the present application for withdrawal of the amount which was deposited by the original opponent No.3 Insurance Company as per oral judgment of dated 29.01.2026 of Hon'ble High Court of Gujarat in **R/First Appeal No. 2611 of 2025** in connection with the award passed by the Ld.M.A.C.T.(Main) Tribunal on dated 05.10.2024 in **M.A.C.P. No.299 of 2016**.

2. According to the report of Nazir, it appears that **Rs.11,83,281/- (Rupees Eleven Lac Eighty Three Thousand Two Hundred Eighty One Only)** stands deposited in the tribunal.

3. In view of the above facts and circumstances, looking to the report of Nazir and as per Order of dated 29.01.2026 of Hon'ble High Court of Gujarat in R/First Appeal No.2611 of 2025, I pass the following order for payment of amount of compensation :-(amount rounded off).

**:- ORDER :-**

(1) The Nazir of the Tribunal is hereby directed to pay the amount of compensation along with the interest etc. to the claimants of MACP No.299 of 2016 after proper identification and due verification, which is bifurcated in following manner :-

<b>Rs.9,160/-</b>	Deducted towards Court Fee
<b>Rs.1,76,118/-</b>	30% amount on the part of claimant No.1 be paid to the original Claimant No.1 Lataben Jigarbhai Damor Pandor by RTGS or NEFT facility in the account No.7945252240 of Indian Bank, Godhra Branch.
<b>Rs.4,10,943/-</b>	70% amount on the part of original claimant No.1 be deposited in any nationalized bank in non-cumulative Fixed Deposit Receipt (FDR) in the name of Claimant No.1 Lataben Jigarbhai Damor for

	the period of five years.
<b>Rs.2,93,530/-</b>	100% amount to be deposited in F.D.R. for a minimum period Five Years or till the minor attain the age of major whichever is latter in any Nationalized Bank in the name of the original Claimant No.(2) Minor Roshniben Jigarbhai Damor through her guardian and next friend his mother Claimant No.(1) Lataben Jigarbhai Damor.
<b>Rs.88,059/-</b>	30% amount on the part of original claimant No.4 be paid to the Claimant No.4 Viraben @ Ramilaben Manglabhai Damor by RTGS or NEFT facility in the account No.7945268318 of Indian Bank, Godhra Branch.
<b>Rs.2,05,471/-</b>	70% amount on the part of original claimant No.4 be invested in Long Term Fixed deposit for the period of 05 (Five) Years in any nationalized bank in the name of the Claimant No.(4) Viraben @ Ramilaben Manglabhai Damor.
<b>Rs.11,83,281/-</b>	<b>Rupees Eleven Lac eighty Three Thousand Two Hundred eighty One Only</b>

(2) Interest on the above said fixed deposit investment as and when it becomes due, shall be paid to the concern claimants periodically as and when it becomes due. However, they will not be entitled to withdraw any amount before maturity or raise any loan from the said investment, without prior permission of this Tribunal.

(3) No loan or over draft or advance, known by any other name or nomenclature shall be made available on the said fixed deposit investment and the bank shall not allow any encumbrance on the said investment without prior permission of this Tribunal.

(4) The Bank Manager shall intimate to this Tribunal the particulars of the Fixed Deposit investment such as date of investment, number of fixed deposit receipt, date of maturity etc. immediately after the issue of fixed deposit receipt.

(5) At the end of the stipulated period of 05 (five) years as aforesaid, the bank shall pay the principal amount of the F.D.R. with interest accrued thereon, if any, directly in the savings bank account of the concern claimant.

(6) This order alongwith copy of Ex-1 of this petition be sent to the Nazir for necessary action.
